



**MEMORANDUM OF AGREEMENT
WITH REGARD TO STUDENT EXCHANGE
BETWEEN**

**GRADUATE SCHOOL OF MEDICINE, SCHOOL OF MEDICINE and
GRADUATE SCHOOL OF HEALTH SCIENCES,
KOBÉ UNIVERSITY, JAPAN
AND
FACULTY OF VETERINARY MEDICINE
UNIVERSITAS AIRLANGGA, INDONESIA**

This Memorandum of Agreement (MoA) is to promote the exchange of students and thereby partly implement the ideals expressed in the Memorandum of Understanding (MoU) between the two institutions concluded on July 17, 2018.

1. Graduate School of Medicine, School of Medicine and Graduate School of Health Sciences, Kobe University and Faculty of Veterinary Medicine, Universitas Airlangga will exchange graduate students and undergraduate students under the following terms:
 - (1) Sending institution shall be responsible for selecting students who are sufficiently qualified to carry out the exchange program. The receiving institution will admit exchange students according to its established policies and procedures.
 - (2) The number of students to be sent from each institution will not exceed 4 (four) for each year in principle. However, both institutions shall make efforts in keeping proper balance concerning the number of students they send to the other.
 - (3) The period of stay for each exchange may be determined by both institutions according to his/her study plan. However it will not exceed one academic year.
 - (4) The status of each exchange student will be “special auditing student” or “special research student” at Kobe University and “exchange student” at Universitas Airlangga.
 - (5) Exchange students’ registration remains in the home institution and students pay admission fees, general fees and tuitions to it. They shall not be required to pay admission fees, general fees and tuition to the host institution.
 - (6) It shall be the responsibility of the home institution to arrange in advance how many of the credits received from the host institution will be accepted toward graduation requirements at the home institution.
 - (7) Each exchange student will be subject to the same regulations as pertain to the students of the host institution.
 - (8) The host institution will endeavor to provide exchange students with accommodations.
 - (9) Living expenses, health and liability insurance and all the other financial obligations will be borne by each exchange student. However, government and/or other scholarships may be used to cover these expenses.

2. This MoA shall be in effect upon signatures from both sides and shall remain in force for the period during which the Memorandum of Understanding between Kobe University and Universitas Airlangga is in force. Each institution may propose amendments to the other institution, or writing advance notification not less than 12 (twelve) months to terminate this MoA.
3. This MoA is signed in identical copies in English, Bahasa Indonesia and Japanese by the authorized representative of each university, the three texts being equally valid. In the event of any divergence of interpretation among any of the texts, the English text shall prevail.




